In 2021, the Organization reorganized its work and priorities to better support local partners and program participants in India to navigate the most devastating stages of the COVID-19 pandemic. The Organization unrestricted its program support grants to give its partners in India maximum flexibility to respond to the unique needs of the communities they serve. The Organization extended the deadline to disburse scholarship grants in order to accommodate school calendar delays and the temporary closure of colleges and universities. Finally, the Organization invested additional organizational time and resources--including hiring a Development Coordinator in Denver--to raise funds and steward supporters and donors more intensely and effectively. This enabled the Organization to sustain its infrastructure and its impact through a deeply uncertain financial year.

Shadhika intends to abate gender-based discrimination and violence in the social systems surrounding each person by focusing on three core areas of intervention: 1) Shadhika provides multi-year scholarships for young women to pursue post-secondary education. Combined with the local accompaniment by our partners, each young woman can build self-confidence, acquire the tools, and achieve the financial independence necessary to control their own bodies and determine their own goals; 2) Shadhika provides multi-year, unrestricted funding to give grassroots leaders the security, the time, and the resources to identify determining factors of vulnerability and incubate

community-centric, sustainable solutions; and 3) Shadhika funds initiatives that engage men and boys-and other power holders-to champion gender justice and recalibrate power structures in their own communities. Shadhika also supports convenings for its partners, Scholars and Alum, and its Advisory Council to learn and co-create together, ensuring local voices are central to effecting change in India.

In 2021, Shadhika gave \$116,878.03 in scholarship funds to 70 Scholars, as well as \$118,724.59 in program support grants and \$17,500 in COVID Emergency Response grants to 7 local organizations. Through these efforts, Shadhika reached 2,724 young women and girls and 1,385 men and boys in 2021 who are changing mindsets about gender norms in their communities.
